Commissioner St. Mary seconded. Motion carried unanimously.

- The department currently has a litigation hold in place due to a pending legal situation.
- It was brought to FC Hille's attention by one of the Lieutenants that there is a barricade on Bridle Way that is hindering response times to incidents in that neighborhood. FC Hille will make calls to the County and find out about getting it removed.
