UNFINISHED BUSINESS

Annexation

DC Lamoureux explained the Yakima County commissioners are proceeding with the annexation study. There are two ways the annex can succeed; the first way would be 60% of the assessed value of the area that they are annexing or 60% of the land mass they are annexing. However, we do not know the exact boarders of the area they are going to annex. DC Lamoureux explained that if the City of Yakima were to annex up to 41st street to included station 42; it would be about 1.4 billion in assessed value. With their taxing structure overlayed on top of that assessed value would be 4.3 million dollars of which would go to the City of Yakima in property taxes. Based off of the City of Yakima's property tax collection from the assessor's office they are at about \$2.20 when you combine that with the assessed value were looking at around 4.3 million. Commissioner Ramynke asked for a clear understanding of the community impact the annexation of Terrace Heights would have.

Commissioner Ramynke stated the communications committee is looking into updating equipment on elephant mountain, which started at \$2,800 and is now around \$4,000 in hopes to improve communication on highway 24.

ANNOUNCEMENTS - None GENERAL DISCUSSION

One million dollars out of the forty million were set aside out of the Yakima County's ARPA funds strictly for the fire service. Our districts request was on the list for top priority which included 12 thermal imaging cameras and 3 gas monitors. Adding up to be almost twenty-two thousand dollars.

April 8th 2023 Yakima County Fire District 4 will be participating in an active shooter drill with the Pacific Northwest University with on duty members as well as encourage Volunteer Firefighters to help run calls. The training will begin at 0900 and end around 1300. Commissioner St. Mary recommended offering career staff overtime in order to get more participation. PNW University would like to make this an annual event.

DC Lamoureux will be representing the Washington State Fire Chiefs February 14th 2023, testifying in front of the house committee on state, government and tribal relations for the regional direct liberty program for volunteers.
